Terms and conditions

1. The reservation will become effective on receipt of your completed booking form together with the deposit and administration fee, confirmation of which will be sent to you. The booking is non-transferable.
2. The camp rules must be complied with by all occupants.
3. The hire period is from 4 pm Saturday to 10 am Saturday. Your reservation will be held for 48 hours after your expected arrival, after which your booking will be cancelled unless we hear from you to the contrary.
4. The balance of the hire charge is payable on the day of arrival, together with a 300€ surety payment, which is refundable upon departure, following a satisfactory check of the accommodation and inventory. All damages or missing items must be paid for.
5. The accommodation must be vacated by 10 am on the morning of departure, unless prior permission has been given by the office. An inspection of the accommodation will be made prior to departure, a charge of 35€ will be made if the accommodation is considered not to be in a satisfactory clean state.
6. Should the booking be cancelled within 30 days of expected arrival, the deposit is non refundable.
7. Domestic animals are not allowed inside the accommodation.
8. There is a 12.50€ administration charge on all bookings which is non returnable on cancellation and non deductible from the total charge.
